Legal Advice

- What is Advice?
 - "To give an opinion or counsel, or recommend a plan or course of action; also to give notice..." – Black's Law Dictionary
- What is Legal Advice
 - To give advice or guidance in a legal setting.
- Characteristics of Legal Advice
 - Requires legal knowledge, skill, education, and judgment
 - Applies specific law to a set of circumstances
 - It affects someone's legal rights or responsibilities
 - Adversarial

Legal Advice

- Who Can Give Legal Advice?
 - Licensed attorneys
 - Legal paraprofessionals* (Arizona Code of Judicial Administration 7-210)
- Examples of Legal Advice Questions:
 - I only took \$300.00 of merchandise, is that shoplifting?
 - Should I retain an attorney?
 - Is this plea a good deal?
 - Should I sue my neighbors for their tree growing on my side of the yard?
 - What is an arraignment?

Legal Information

- What is Legal Information?
 - Means general factual information about the law and the legal process. Legal
 information is different from legal advice, which involves giving guidance
 regarding an individual's legal rights and obligations in light of his or her
 particular facts and circumstances. Legal information is neutral.
- Characteristics of Legal Information
 - Factual based
 - Process oriented
 - Non-adversarial neutral
 - Informative
 - · Helps an individual understand a process/procedure

Legal Information

- Who Can Give Legal Information?
 - Court Clerks
 - Someone knowledgeable and credible in the field
- Examples of Legal Information Questions:
 - What is a motion?
 - How do I request a record?
 - What is the difference between an order of protection vs. inj. against harass.
 - Do I need to appear for court?
 - Should I file this motion?

Advice vs. Info Comparison


- Legal Information
 - Can be provided by court clerks
 - Explaining court forms
 - "These forms are used for..."
 - Explaining court processes and procedures
 - -"The process for this is..."

- Legal Advice
 - Can only be provided by lawyers (judges?)
 - Completing forms or tell what to write
 - "You should write this on the form..."
 - Recommending what steps to take and representing someone in court
 - -"I would recommend that you..."
 - -"You should tell the judge about..."

Advice vs. Info Comparison

- Legal Information
 - General information about process
 - Explaining common legal words
 - -"This term means..."
 - Referring people to resources
 - "You can go to this website..."
 - Telling a person they need to get more help and advice

- Legal Advice
 - Applying law to specific situation
 - Preparing legal documents
 - "This document says...which means you..."
 - Recommending what steps to take and representing someone in court
 - -"I would recommend that you..."
 - Giving an opinion on any part of a person's legal problem





Clerk Do's and Do Not's

• DO's

- Give procedural explanation and information
- Help people understand the process
- Explain the orders of the court
- Provide consistent public service
- Review forms to ensure completeness
- Explain instructions on the form

DON'Ts

- Give recommendation, advice, or opinions
- Tell people what the judge is going to rule
- Tell people what to say
- Tell people what to write
- Suggest what will happen to the case
- Advocate for the individual
- Research (beyond our scope) for the individual
